

# PRESIDENT'S REPORT

The 101st season for the South West Rocks Surf Life Saving Club saw us achieve another great season in all aspects of our operations, as we continued to navigate the impacts of COVID-19. Our AGM saw all positions on the Board of Directors filled, with some fresh faces, bringing great ideas and enthusiasm to their portfolios. There have been some notable achievements, and we have strived to build stronger relationships within the community and provide facilities and pathways for our members.

The active membership remained steady which allowed our patrols to operate efficiently and effectively. With sixty patrolling members we were able to provide 2300 hours of volunteer patrols on the beach. With a higher than normal beach attendance and many being first time visitors to the area kept our hard working patrolling members on their toes.

Our Call Out team and local Duty Officers were kept busy with a higher than normal out of patrol hour call-outs. We had four of our members start their RWC (jetski) training to become members of the SLSMNC Support Operations Team. There was a major search which spanned over five days for a missing spear fisherman off Laggers Point at Trial Bay. This search included members from almost all clubs within the Mid North Coast and was truly a team effort, unfortunately the man is still missing to this day.

SWRSLSC held the second Branch carnival in poor conditions, which saw some events cancelled. We also provided water safety for the annual Trial Bay Triathlon and First Aid for the Macleay Running Festival.

Our Mens Masters Surf Boat Crew showed some promising results in the North Coast Boat Series as well as at Aussies where they made the semi-final. Some other major carnivals for the surf boat fraternity were cancelled throughout the season. A Womens Masters Surf Boat Crew also emerged towards the end of the season competing in some local carnivals.

The Trainers, Assessors and Facilitators have been busy this season with awards being gained across most areas, especially in the IRB arena. Four IRB Crewies were awarded as well as three new IRB Drivers. Our three new drivers are the first female drivers in the club for a number of years – a very important milestone for the Club in what was the 40 Year Anniversary of active female lifesavers. Our Club needs more trainers and assessors to assist with the long hours that our current TAFs do. The education portfolio is a large and important one, that directly supports the skill development of our new and current members.

Congratulations to Ian 'Spook' Everingham who was named the SLSMNC 'Trainer of the Year' for this his 60th season of active patrols. He will now go up against the best Trainers in NSW for the State Award.

The Nippers did a great job with their Sunday morning sessions. We had reduced numbers this year, but this didn't stop the fantastic support from Renee and her team of Age Managers and Water Safety that were always there to lend a hand.

With the assistance of Kempsey Shire Council the rock sea wall was completed after a number of interruptions due to weather and then COVID-19. This works project was in the pipeline for almost twenty years and on its completion supports the area in front of the surf club from erosion, as well as providing a much safer access for beach goers. Thank-you to the Kempsey Shire Council for their support of this much needed project.

The Bar and Bistro has been trading steadily, with a very busy Christmas season. All governance requirements have been adhered to, including enforcing COVID-19 restrictions. Our new Club Manger, Alex Wilcox, has taken the reigns and is doing a sensational job, in what is currently an everchanging environment. Thank-you to Alex and her team on continuing to provide a great venue for both locals and visitors alike.

Investigations have begun regarding a new premises which will incorporate some of the original area of the clubhouse. The building is currently past its functional life with many aspects including storage and structural concerns. For us to remain sustainable and provide our community service we need to provide modern facilities for our members to perform their duties effectively. We also need to provide a space for the broader community and business streams to facilitate our core functions such as nippers, lifesaving, emergency response, member development, surf sports and a place for members and guests to enjoy our first class view.

Unfortunately we have had to postpone some events to later on in the year due to COVID-19 - the 50 Years Country Branches Reunion and the SLSNSW Sharkskin IRB Championships. We hope that both these important events will go ahead in the near future.

I would like to acknowledge the assistance and support from Surf Life Saving New South Wales, Surf Life Saving Mid North Coast, Federal MP Pat Conaghan, State MP Melinda Pavey and Kempsey Shire Council Mayor Liz Campbell. Our local sponsors and supporters have once again shown their loyalty to the Club even through the current uncertain times.

Thank-you to the Board of Directors and Management Committee who continue to put in many hours on top of their patrolling obligations.

I look forward to the 2021/22 season which will hopefully bring more stability in general across all aspects of surf lifesaving.

# DIRECTOR OF ADMINISTRATION

This past Season has been an interesting but challenging one, with many of us being a position to re-evaluate our priorities and working circumstances as a result of the circumstances arising from the COVID virus.

It is an apt time for us all to remember the importance of having volunteer lifesavers on our beaches, and what the goal and purpose of the South West Rocks Surf Life Saving Club is. Sitting in this position for the first time has highlighted to me how much work and effort goes on behind the scenes to provide the services we do – and the old adage "many hands make light work" rings very true. # DIRECTOR OF LIFESAVING

The 2020/21 season once again showed the resilience and commitment from our members. The soaring visitor numbers kept our patrolling members busy across the entire season.

The active membership remained steady which allowed our patrols to operate efficiently and effectively. With sixty patrolling members we were able to put just over 2300 hours on the beach. During patrolling hours our six patrol teams performed six rescues, twenty-two first aid treatments and 589 preventative actions.

Thank-you to the Patrol Captains for their support this season. Sometimes a thankless role, our Patrol Captains do their best to ensure that we adhere to our Lifesaving Agreement requirements.

Our top patrolling members showed just how much effort our members put in on the beach – Stu Cole 84. 25 hours, Rebecca Mitchell 81.25 hours, Paul Owens 74.5 hours, Dave Pearson – 74 hours, Rod McDonagh – 66 hours, Vicki Thomas – 66 hours, Mark Notley – 64 hours, Bobbie Brenton – 59 hours and Darren Love – 59 hours.

Our Call-Out Team and local Duty Officers were kept busy with a higher than normal out of patrol hour call-outs, due to the increase of first-time visitors to the area. There was a major search which spanned over five days for a missing spear fisherman off Laggers Point at Trial Bay. This search included members from almost all Clubs within the Mid North Coast and was truly a team effort, unfortunately the man is still missing to this day.

Our Education Team, under the guidance of Ian 'Spook' Everingham, showed commitment in delivering a wide range of awards, including: Surf Rescue Certificate x 1, Bronze Medallion x 3, Advanced Resuscitation Techniques x 13, First Aid Certificate x 3, IRB Crew x 4, Silver Medallion Beach Management x 1, Silver Medallion IRB Driver x 3 along with twenty-six Junior Education Awards.

# DIRECTOR OF JUNIOR ACTIVITIES

We held two pre-season sign up days in September and a third in October. Numbers were stronger again than the last two seasons and continued to build right through till we commenced our Nippers after the October school holidays. We had to add extra pool proficiencies swims due to popular demand. Attendances at Nipper days were very good with about 85% turning up each Sunday. Unfortunately attendances at Carnivals is still low but at least it was better than last season so we can keep building on this momentum and encourage more Nippers (and families) to join in the fun and comradery of carnivals which also allows for skill development and competition opportunities. The weather also hindered carnivals this season but South West Rocks still had Nippers represented at all Branch Carnivals including Championships that occurred and for some it was in very tough conditions but they had a go and did us proud. County Championships at Kingscliff was cancelled this season due to Covid.

An Age Manager course was held at SWR before the season commenced, we had two members complete the course, both were non parent members of any nippers and this is an area that needs to be addressed, more families of Nipper children need to step up and take on some of the roles including Age Manager Positions. We cannot keep relying on others to fill the gaps parents leave. Age Managers and their children along with 2 other families allowed for the Sunday Nippers to be set up and ready by the time other families arrived. Thank you to the McLeod and Mackay families for your consistent support in setting up the beach each week and to Stu Cole for assisting every week with water safety. We were also lucky to have the support of local business each Sunday who provided encouragement vouchers for the Nippers – Chillati-gelato & sorbet and Lou's Café.

Covid once again hindered our ability to fundraise with any real consistency, we secured a Grant from the Kempsey Shire Council to purchase two new bigger fibreglass boards, and these will assist the older members as they had outgrown the boards we have. Thank you to Steve Smailes for spending many hours arranging the boards and delivery.

We continued completing cleaning, tidying and organising jobs that we started last season including the Nipper Board Room, The Nippers Room, and The Nipper Handbook.

The new website has a dedicated Nippers section as well which will continue to be built on. Kristy McLeod continues to do a great job taking photos every week and posting them to the Facebook page, we are utilising the Facebook page as our main way to promote Nippers and share information and it is looking good with all the photos! Thank you Kristy.

Macleay Nippers, is such an amazing program that allows for all our 3 small Macleay clubs to come together to learn from each other and provide our Nippers with additional competition, skills and comradery that they can take to Branch Carnivals to be more competitive with the other larger clubs. Unfortunately the weather saw only SWR hold the Macleay Nippers this season, Crescent Head and Hat Head's had to be cancelled due to rough weather. Both clubs are still wanting to continue this program next season and I would encourage that very much.

We had an excellent turn out for the rescheduled Nippers Presentation due to the Macleay flood event, the disco was a huge success, something to consider as a fundraising event during the school holidays! We enjoyed nibbles from the bistro, had Age Managers, Life Member Anne Pearce and Sponsors present awards to each age group. The major award winners were very deserving – Ruby McLeod – Kerry Fisher Memorial Award for Effort and Attitude – Katherine McKay – Competitor of the Year

### 2020 / 2021 Season Gym Member Notice

You should have all by now completed the online and free NSW Government COVID-19 Awareness for Gyms training <a href="COVID-19 guidance for gyms (nsw.gov.au">COVID-19 guidance for gyms (nsw.gov.au</a>) and are fully aware of the importance of Hygiene and Cleaning of the Gymnasium area for the purposes of our COVID-19 Safety Plan.

There have now been several warnings issued to all Gym Users regarding the cleaning roster and lack of compliance, with the last warning issued by SMS from Brienna Elford on behalf of Mark Notley on 12 June 2021. This was an attempt to improve the current situation and place a fair responsibility on all gym users, particularly during the COVID period.

Since that time the gym has only been cleaned once, resulting in the matter being escalated to the Board for direction and action.

A recommendation has been put forward to remove the current subsidy available to patrolling members as it will be necessary to secure the services of a cleaner once a week. This will mean that the annual membership for all active members will increase to \$250 per annum (still less than \$5 per week.)

This motion will be put to the Annual General Meeting (AGM) on 1 August 2021, where voting members in attendance will be asked to vote on the motion. If you wish to dispute this motion it is strongly recommended you attend the AGM. A change of behaviour would also be strongly recommended if current privileges are to be supported.

The Committee has acted in good faith for many years to maintain a healthy environment and provide new equipment in the gym, with all of these costs being borne by the Club. Unfortunately this is no longer sustainable due to lack of action by some gym users.

# **Gymnasium Rules**

The gymnasium is a combined project between the South Wet Rocks Surf Life Saving Club and the South West Rocks RSL Sub-Branch.

The gymnasium is not a facility for the general public and the following rules must be adhered to:

### MEMBERSHIP

Gym fees as adopted by at the Annual General Meeting on 1/8/2021:-

- Gymnasium fee annual: \$250

- Only current active financial members of SWRSLSC can enter the gym DO NOT invite any non-club members into the clubhouse to use the facilities. Non-members are not covered by insurance. This will be monitored and policed. Offenders will have their access to the gym denied
- All gym members must have undergone an induction from the Gym Coordinator.
- All gym members must sign the attendance book on entry.
- Scheduled classes take preference over all other use.

### EQUIPMENT

- All equipment is to be returned to its allocated storage space after use.
- All equipment is to be cleaned and sanitised after use with products provided.
- Members are required to place a towel on benches when using equipment.
- Members who notice any broken or damaged equipment should notify the Gym Coordinator immediately.

### SAFETY

- All members will comply with the COVID requirements displayed at entry, including any check in requirements.
- The gym is a SAND, GLASS, FOOD, SMOKING, CHILDREN, PET free area.
- No member is to be under the influence of alcohol or drugs whilst using the gym.
- Members must wear the correct gym apparel which includes -t-shirt/singlet, covered
  footwear, and shorts/tights. Members are not allowed to enter the gym in their swimmers
  or thongs. Any jewelry that may be possible to injure a user, including rings and necklaces, is
  not permitted. Small earrings and items that cannot inhibit or injure a user are permitted.
- Members who obtain an injury in the gym must notify the Gym Coordinator immediately.
- If you are on your own, or the last person in the gym, switch off all lights and fans, close the windows and lock the door.
- If you are participating in a group class, you must inform the instructor of any health conditions which may limit your ability to participate in some activities.
